

AN ORDINANCE OF THE CITY OF LEANDER, TEXAS

ORDINANCE NO. 18-033-00

AN ORDINANCE CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE MAY 5, 2018 GENERAL ELECTIONS OF THE CITY OF LEANDER, TEXAS

WHEREAS, pursuant to the Texas Election Code, the City Council of the City of Leander, Texas, convened on this the 14<sup>th</sup> day of May, 2018 at 5:30 p.m. for the purpose of canvassing the vote in the General Election held on May 5, 2018.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEANDER, TEXAS, THAT:

SECTION ONE. Canvass of Vote. There came to be considered the returns of the general election held on the 5<sup>th</sup> day of May, 2018, for the purpose of electing a mayor and three council members, and it appearing from said returns, duly and legally made, that there were cast at said election 2364 votes (*total votes*); and that each of the candidates in said election received the following votes:

**SECTION TWO. Finding and Declarations.** It is found, determined and declared by the City Council that said election was duly called; that notice of said election was given in accordance with law, and that said election was held in accordance with law; and that: Michelle Stephenson was duly elected to the City Council, Place 2; Christine Sederquist was duly elected to the City Council, Place 4, and Marci Cannon was duly elected to City Council, Place 6. Said above named parties are hereby declared duly elected to said respective offices, subject to taking of their oaths of office as provided by the laws of the State of Texas. As no candidate for the office of Mayor received a majority of the vote as required by the City Charter, the City Council will order a runoff election for the office of Mayor by separate action in accordance with state law and the City Charter.


