CHOOSE ONE PLEA for the offense above. *(if you have more than one offense and wish to enter different pleas, you must use different plea forms for each offense.)*

PLEA:

I hereby enter a plea of NOLO CONTENDERE (NO CONTEST) and waive my right to a jury trial. (No Contest is treated the same as a guilty plea. Nolo Contendere is a Latin phrase meaning "I will not contest it, however I do not admit guilt.")

I hereby enter a plea of GUILTY and waive my right to a jury trial. (Guilty means you admit your guilt and are willing to pay the fine. Discussing the case with the Judge is permissible once a plea of Guilty is entered.

By paying the fine you are waiving your right to receive discovery information pertaining to your case. If you are requesting discovery information in regards to your case you must follow the rules of Texas Criminal Procedure.

*I hereby enter a plea of NOT GUILTY and waive my right to a jury trial and request TRIAL BY JUDGE.

*I hereby enter a plea of NOT GUILTY and request TRIAL BY JURY.

(If you enter a plea of NOT GUILTY, you will be notified by mail of your court date)

By checking this box, I acknowledge that I have posted a Cash Bond and I am entering a plea of NOT GUILTY. I understand that if I fail to appear at the date and time noted on my cash bond paperwork given to me at the time I posted the bond, or at any time the court requires my personal appearance, I waive my right to hire an attorney and to a jury trial and plead nolo contendere ("no contest") to the offense charged. I understand that this bond will be forfeited to satisfy the fine and costs that the judge assesses and that my plea will result in a conviction which will appear on my criminal record and driving record.

*****You must appear in person if you are charged with any of the following:** Assault Family Violence (of any age), Minor with an alcohol offense, Minor with a Driving Under the Influence, Public Intoxication under the age of 21, or any offense if you are a juvenile (under the age of 17). ***
