### VENDING RULES:



1. The City reserves the right to accept or reject any applicant.
  3. The Sale of alcoholic beverages is prohibited (*limited to VFW and VFW grounds*).
  4. All vendors are subject to inspection by the Fire Marshal prior to the event starting.
  5. All vendors must make application, pay applicable fees, and gain approval prior to the event.
  6. Vendors must identify specific items or products to be sold. Once the vendor's application is approved, the vendor must agree to limit sales only to approved items. Main food entrees will be prohibited. The VFW Post will be selling BBQ plates and those funds will go to the Veterans Park Project. This rule will be strictly enforced.
  7. Vendors are responsible for providing all items necessary for their booth. The event provides space only. Vendors requiring electricity must furnish their own generators.
  9. **Fees:** *Not-for-Profit Groups* - \$50, *Private Businesses/Individuals* - \$100, and *Veteran Service Organizations* – No Fee
  10. Fees should be made payable to the "City of Leander" and please write "Veterans Park Project" on the check memo line.
